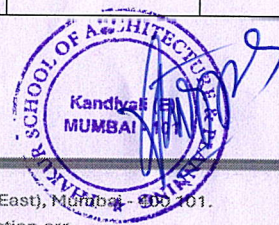
1) Rajarshi Chhatrapati Shahu Maharaj Shikshan Shulk Shishyavrutti Yojna – 2026-27.

Eligibility Criteria: -

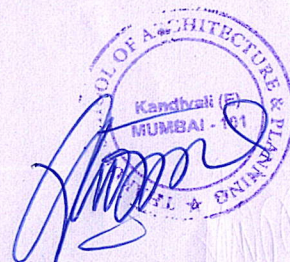
- Applicant should have Nationality of India.

- Deemed University and Private university is not applicable.
- Candidate should be admitted through Centralized Admission Process (CAP).
- Applicant should not avail any other scholarship/stipend.
- For current Academic Year, Only 2 child from family are allowed for benefit of scheme.
- Total Annual Income of Family / Guardian should not be more than Rs. 8,00,000/- Eight Lakhs.
- Minimum 75 % attendance in previous semester (Exception for fresh admitted in College).
- During course duration, candidate should not have a gap of 2 or more than 2 years.

2) Dr. Punjab Rao Deshmukh Hostel Maintenance Allowance Scheme. – 2026-27.

All the B.Arch. students admitted through CAP Round of the college and staying in Hostel are hereby informed that, this is a plan for students of government, government funded and non-affiliated colleges / polytechnics entering the vocational courses set by the government, whose students are certified by the competent authority, as a marginal farmers or whose parents are registered laborers.
